# **January 6, 2020**

The Annual Organizational Meeting for the Year 2020 of the Board of Fire Commissioners of the Ridge-Culver Fire District was held at the firehouse, 2960 Culver Road, in the Town of Irondequoit on January 6, 2020.

Commissioner Warth opened the meeting at 6:00 p.m. and then led the Pledge of Allegiance.

Those in attendance were: Commissioners Timothy Warth, Michael Napoli, Mark Lipari, Robert Woltz, Scott Zampatori, Treasurer Patricia Marini, Acting Chief Mark Thomas and Captain Quinlan

- Motion was made by Commissioner Warth, seconded by Commissioner Woltz that Commissioner Napoli be
  designated by the Board to act as Temporary Chairman until such time as a Chairman of Board of Fire
  Commissioners is chosen. "Motion Carried".
- The seat of Chairman of the Board for the Year 2020 was now open. Motion was made by Commissioner Napoli, seconded by Commissioner Lipari that Commissioner Warth be appointed Chairman of the Board for the Year 2020. "Motion Carried".
- Motion was made by Commissioner Lipari, seconded by Commissioner Zampatori that Commissioner Napoli be appointed Vice Chairman of the Board for the Year 2020. "Motion Carried".
- Motion was made by Commissioner Lipari, seconded by Commissioner Zampatori that Patricia Marini be
  appointed Treasurer of the Ridge-Culver Fire District for the Year 2020. Treasurer is to be responsible for VFBL
  Compensation Insurance Forms 1, 2, and 3. "Motion Carried".
- Motion was made by Commissioner Napoli, seconded by Commissioner Woltz to compensate the Treasurer of the District \$25.00 per hour, received in bi-weekly payments for the Year 2020. "Motion Carried".
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori, that the Board of Fire Commissioners hold their regular monthly meetings on the first and third Mondays of each month with some exceptions based on holidays and with the exception of July and August when there will only be one meeting on the second Monday of July and first Monday of August. There will be one additional meeting for the Budget Hearing on October 13th. The Board has added additional "Workshop" meetings on January 20<sup>th</sup>, March 9<sup>th</sup>, June 18<sup>th</sup>, September 21<sup>st</sup>. All meetings will start at 6:00 p.m. for the Year 2020. "Motion Carried". Media has been notified.
- Motion was made by Commissioner Zampatori, seconded by Commissioner Napoli, to designate Post Newspapers and Gannett Rochester Newspapers as the official newspapers of the district with the ability to use either of these papers for official publications. "Motion Carried".
- Motion was made by Commissioner Lipari, seconded by Commissioner Woltz, to use Key Bank and Canandaigua National Bank and Trust where the Treasurer shall deposit funds for the Year 2020 except C.D.'s, which will be deposited in the highest interest-bearing Federal Bank. "Motion Carried".
- Motion was made by Commissioner Lipari, seconded by Commissioner Zampatori, that the Treasurer of the Ridge-Culver Fire District be able to pay recurring claims for services such as electric, gas, water, sewer and telephone as long as such claims are presented for audit at the next regular board meeting after they have been paid. "Motion Carried".
- Motion was made by Commissioner Lipari, seconded by Commissioner Napoli, that Peter Weishaar, 25 East
  Main Street, Rochester, New York 14614, be hired as the Ridge-Culver Fire District's lead attorney for the Year
  2020, and Coughlin Gerhart, LLP, Attorneys at Law, 99 Corporate Drive Binghamton, NY 13904 to be hired as the
  district's secondary attorney for the Year 2020. "Motion Carried".
- Motion was made by Commissioner Lipari, seconded by Commissioner Zampatori, that the Fire District Officers of the Ridge-Culver Fire District attend any New York State Conference and a maximum of 1 out of state conference. District is to pay necessary dues and expenses for those attending. "Motion Carried.

- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori, that dues for different firematic organizations for district officers and chiefs be paid by the district. "Motion Carried".
- Motion was made by Commissioner Napoli, seconded by Commissioner Woltz, that all commissioners, the secretary and treasurer be covered by fire district insurance while on any business or work covered by his or her title. "Motion Carried".
- Motion was made by Commissioner Lipari, seconded by Commissioner Woltz, that all fire district officers are allowed the Federal allotted mileage allowance, travel expense, and be allowed \$75 per day for meals while out on district business for the Year 2020. "Motion Carried".
- Motion was made by Commissioner Zampatori, seconded by Commissioner Lipari, to use the Trust & Agency Fund for the account to be used as a transfer agent for the 2% foreign fire insurance. The account is to be held at the Key Bank or Canandaigua National Bank & Trust, Irondequoit Office. "Motion Carried".
- Motion was made by Commissioner Woltz, seconded by Commissioner Lipari, that the District Treasurer is allowed 60 days to prepare and present to the Board the Annual Treasurer's Report and that the Board will review vouchers, checkbook, cash book, and expenditures for the Year 2020. "Motion Carried".
