- Motion was made by Commissioner Warth, seconded by Commissioner Zampatori that Secretary Riesenberger be designated by the Board to act as Temporary Chairman until such time as a Chairman of Board of Fire Commissioners is chosen - APPROVED.
- The seat of Chairman of the Board for the Year 2022 was now open. Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori that Commissioner Warth be appointed Chairman of the Board for the Year 2022 **APPROVED**.
- Motion was made by Commissioner Warth, seconded by Commissioner Zampatori that Commissioner Napoli be appointed Vice Chairman of the Board for the Year 2022 - APPROVED.
- The Board re-elected (or appointed) Board Member Mark Lipari for a five-year term. Commissioner Lipari will be sworn into office by the Irondequoit Town Clerk and is asked to turn in the receipt of his Oath of Office Certificate to the District Secretary.
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori that Chief Sessler be appointed Fire Chief of the Ridge-Culver Fire District for the Year 2022 **APPROVED**.
- Motion was made by Commissioner Zampatori, seconded by Commissioner Napoli that Patricia Marini be appointed Treasurer of the Ridge-Culver Fire District for the Year 2022 **APPROVED**.
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori that Rodd Riesenberger be appointed District Secretary / Deputy Treasurer of the Ridge-Culver Fire District for the Year 2022 - APPROVED.
- Motion was made by Commissioner Zampatori, seconded by Commissioner Napoli to compensate the Treasurer of the District <u>\$29.40</u> per hour, received in bi-weekly payments for the Year 2022 -APPROVED.

- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori to compensate the Secretary/Deputy Treasurer of the District <u>\$28.00</u> per hour, received in bi-weekly payments for the Year 2022 - **APPROVED**.

- Motion was made by Commissioner Zampatori, seconded by Commissioner Napoli, to use Canandaigua National Bank and Trust where the Treasurer shall deposit funds for the Year 2021 except C.D.'s, which will be deposited in the highest interest-bearing Federal Bank **APPROVED**.
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori, that the Treasurer of the Ridge-Culver Fire District be able to pay recurring claims for services such as electric, gas, water, sewer, and telephone if such claims are presented for audit at the next regular board meeting after they have been paid **APPROVED**.
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori, that Peter Weishaar, 25 East Main Street, Rochester, New York 14614, be hired as the Ridge-Culver Fire District's lead attorney for the Year 2022, and Coughlin Gerhart, LLP, Attorneys at Law, 99 Corporate Drive Binghamton, NY 13904 to be hired as the district's secondary attorney for the Year 2022 – APPROVED.
- Motion was made by Commissioner Zampatori, seconded by Commissioner Napoli, that the Fire
 District Officers of the Ridge-Culver Fire District attend any New York State Conference and a
 maximum of 1 out of state conference. District is to pay necessary dues and expenses for those
 attending APPROVED.
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori, that dues for different firematic organizations for district officers and chiefs be paid by the district **APPROVED**.
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori, that all commissioners, the secretary, and treasurer be covered by fire district insurance while on any business or work covered by his or her title **APPROVED**.
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori, that all fire district officers are allowed the Federal allotted mileage allowance, travel expense, and be allowed <u>\$75.00</u> per day for meals while out on district business for the Year 2022 - **APPROVED**.

- Motion was made by Commissioner Zampatori, seconded by Commissioner Napoli, to use the Trust & Agency Fund for the account to be used as a transfer agent for the 2% foreign fire insurance. The account is to be held at the Canandaigua National Bank & Trust, Irondequoit Office - APPROVED.
- Motion was made by Commissioner Napoli, seconded by Commissioner Zampatori, that the District Treasurer is allowed 60 days to prepare and present to the Board the Annual Treasurer's Report and that the Board will review vouchers, checkbook, cash book, and expenditures for the Year 2022 -APPROVED.
