State Fire District's Attorney, Joe Frank and the RCFD Attorney, Peter Weishaar have agreed that this new law passed by NYS and adopted by Monroe County has been created for the purpose of volunteer firefighter recruitment and retention. The interpretation of this is to be used for RCFD active volunteer firefighters who have been members in good standing for a minimum of two (2) years or members who are currently classified as "life active members" for more than twenty (20) years. This is not meant to be used as a "thank you" to previous members who are no longer active firefighters. The Town of Irondequoit is understanding that this law includes past members who are no longer active. We will be sending a list of active members and all past members who have been firefighters in the past. The public hearing was closed at 6:15pm.
